




Option 3: Eddleston Water 75 Year Direct Defences, with Bridge & Weir Removal

OPTION SUMMARY. Direct defences along both banks of the watercourse through Peebles. This involves the installation of flood walls in addition to the removal of three weirs and replacement of Bridgegate bridge with a structure with a higher soffit. These additional works reduce the flood wall height and give a higher standard of protection.
